



Collection and Storage After Sale

When you have paid, we will issue you with a 'Buyer Collection' note, which you will need to present to our nominated shippers, Ward Thomas Removals Ltd. Please keep your 'Buyer Collection' note in a safe place.

Lots are at the buyer's risk from the fall of the hammer.

We strongly urge all successful buyers to pay for their items on the day of the sale, and to make arrangements with Ward Thomas Removals Ltd, for the removal of their items. Agents from Ward Thomas Removals Ltd will be on site at Great Brampton House throughout the sale and designated collection period.

All electrical items in this sale will be operationally disabled before they are collected. We recommend that any reconnection work is carried out by a suitably qualified electrician.

Collections during the sale period will be on a first-come-first-served basis. At busy times you may have to wait for your collection.

You will need to provide photographic evidence of identity (driving licence, ID card) together with a Bonhams collection note in order for Ward Thomas Removals Ltd to release your items to you.

If you are sending an agent on your behalf to collect your purchases, they will need to bring:

- 1) A letter of authority from you confirming the name of your agent
- 2) A copy of the purchase release form provided by Bonhams (issued to you upon payment of the item)
- 3) Photographic ID

All sold items will be held at Great Brampton House and will be available for collection, without charge, over the following period:
Wednesday 1 October 10am – 9pm
Thursday 2 October 9am – 5pm
Friday 3 October 9am – 1pm

Thereafter all remaining items will be removed to Ward Thomas Removals Ltd and will be available for collection from 07/10/2008

Handling and Storage Charges

All sold lots will be subject to the following handling charges (excluding VAT):

£60.00 for all over size items (requiring more than two men to lift or mechanical handling equipment)
£40.00 for all other items

Some items will require crating, crates will be charged to the buyer.

All sold lots removed to Ward Thomas are covered for loss or damage by Ward Thomas Removals Ltd at the sum of the hammer price plus buyer's premium. 0.4% of the invoice value, payable annually in advance, will be charged by Ward Thomas Removals Ltd for loss and damage cover.

For sold lots removed to Ward Thomas Removals Ltd, storage charges will be payable before lots can be released.

Lots will be stored free of storage charges for 7 days from Tuesday 07/10/2008. After 7 days, the charges (excluding VAT) levied by Ward Thomas Removals Ltd are as follows:

Daily storage (no charge at weekends)
£6.00 Over size items (requiring more than two men to lift or mechanical handling equipment)
£3.00 Standard items (one or two men to lift)
£1.00 Small items (less than 10kg)

Lots will be available for collection from the warehouse of Ward Thomas Removals Ltd on 07/10/2008 from 09:30 and then every working day between 9.30am and 4.30pm. (Please note – buyers need to be on site at Ward Thomas by 4.00pm).

Payment of storage Charges

All charges due to Ward Thomas Removals Ltd must be paid by the time of collection from their warehouse.
